I refer to your application under the *Freedom of Information Act 1991* (the FOI Act), received by the Department of Human Services (DHS) on 4 November 2021 seeking access to:

Documents, such as audits, ministerial/executive briefings and attachments, reports, executive meeting minutes, and reviews relating to one or more of the following: 1. Working With Children breaches. 2. Working With Children clearances that have been revoked and why. 3. Working with Children system faults/fraud/errors. Timeframe: Since 1 January, 2019 to the date of this application.

I apologise that DHS did not make a determination within 30 days as required by the FOI Act. However, DHS has continued to process your application outside of this timeframe. Section 19(2)(a) of the Act provides that an agency can release documents outside of the thirty-day timeframe, and this is still taken to be a determination under the FOI Act.

Nine documents were located that fit within the scope of your request and I have determined to release six of these to you in part and three in full.

Please find enclosed a copy of the documents released, and a document schedule containing a brief description of each document and determination in summary form.

Documents 4, 8 and 9 contain information relating to the personal affairs of third parties. I consider that it would be unreasonable to disclose this personal information and have determined the information to be exempt pursuant to clause 6(1) of Schedule 1 of the Act. In accordance with section 20(4) of the Act, I consider that you would wish for access to the rest of the documents after exempt information is removed and am therefore releasing these documents to you in part.

If you are dissatisfied with my determination, you can seek an internal review by writing to the Chief Executive, DHS, as the Principal Officer of the agency. Your request should be sent within 30 days of your receipt of this letter.

PURPOSE

To provide an update on the management of the data breach of applicant's personal details while accessing the iApply form to undertake a screening check.

KEY POINTS

- On 28 May 2019, in anticipation for enabling applicant initiated screening applications, Screening Unit ("SU") implemented the new iApply form for a pilot of 9 student applicants from Flinders University.
- On 3 June 2019 SU initiated another 26 applications for Flinders University and 38 applications for Uni SA. A total of 73 applications.
- On 4 June 2019, the SU were advised that a student applicant had advised her university (UniSA) that she was able to see other student's applications.
- On 4 June 2019 at approximately 4.30pm the SU investigated and closed down access to the iApply site.
- A full audit of the system has been undertaken to identify what personal data was visible or accessible to other students. It identified that 43 students had been impacted.
- The SU has contacted all 43 affected students via telephone and/or email. Eleven (11) students have not responded to that communication despite repeated attempts to contact them.

PURPOSE

To provide you with a proposed response to correspondence received by the Privacy Committee in relation to the iApply platform privacy breach and advise that the Screening Unit had addressed the additional actions requested by the Privacy Committee prior to receiving the correspondence.

KEY POINTS

- The Privacy Committee has requested that the Department specifically inform the 15
 applicants whose personal information was known by the Screening Unit to be viewed by
 other students that this information was accessed as a result of the privacy breach (if the
 Screening Unit had not already undertaken this action).
- The Screening Unit has informed 7 of applicants that their personal information was visible to other students and has made the attempts to notify the remaining 8 students.
- The Privacy Committee has asked what actions will be taken by DHS to reduce the likelihood of a future privacy breach.
- A future data breach of this nature is highly improbable since the correct restricted access security profiles are set in the live environment accessed by the public and will remain permanently at this security setting.

DISCUSSION

The Privacy Committee has written to you requesting that the Department of Human Services inform the 15 applicants, whose information was confirmed to have been accessed by other students, that it is known to the department that their information was at least viewed by someone other than themselves.

On 7 June 2019, the Screening Unit Director personally attempted to telephone the 15 applicants whose information the Screening Unit determined had been viewed by other students and left messages for those applicants he could not reach to call the Screening Unit back.

The Screening Unit was able to make telephone contact with 7 of these students to advise that their personal data was visible to other students and explain the specific personal information related to that applicant that was able to be viewed. Screening Unit staff utilised a call script to assist them clearly explain to the affected applicant the impact of the breach in relation to their personal information.

The Screening Unit Director and other Screening Unit Customer and Business Services staff who attempted to make follow up calls were unable to reach 8 of the 15 students by telephone despite multiple attempts. The Screening Unit left voices messages and emailed the students asking them to make contact.

The Screening Unit piloted the iApply application form with this small group of university students to identify any issues before the form was deployed for public use on 1 July 2019 to coincide with the introduction of the working with children check. The purpose of the pilot was to trial the form was with this small cohort of applicants so that any issues could be identified in a controlled environment.

The privacy breach was a significant issue that emerged from the pilot. However, the cause of the breach is known and well understood by DHS, DPC, and the DWS (the iApply product vendor). The application form went live for public use on 1 July 2019 with the correct security profile. The Screening Unit advises that a future data breach of this nature is highly improbable since the correct restricted access security profiles are set in the live environment accessed by the public and will remain permanently at this security setting.

The Screening Unit contacted the Privacy Committee and advised that the response to their correspondence will be received after the requested date. The delay being due to the quantum of information related to the breach requiring review in order to respond to the Privacy Committee. In future, the Screening Unit will seek an extension if there is a delay.

Thank you for your correspondence advising that the Privacy Committee of South Australia has met to consider the Screening Unit's data breach that occurred through the iApply platform during a pilot undertaken with the University of South Australia and Flinders University.

The Department apologises for the delay in responding to your letter. This was due to the time taken for all information related to applications impacted by this breach being reviewed and checked.

The Department acknowledges that the privacy breach was a significant issue that emerged during the pilot caused by an incorrect security profile while the application form was in pilot mode.

The Department resolved after the breach that it would only proceed with deployment of the screening application through the iApply platform for use by the general public once agreement was reached with Department for the Premier and Cabinet (DPC) and DWS (the iApply vendor) that the form was secure and suitable to be launched in the live environment.

The Department worked closely with DPC and DWS following the breach to satisfy itself that the iApply platform could safely be used for screening by the general public. The Department decided it would only launch the form once it had conducted the necessary due diligence and thorough testing. The application form was deployed for public use following this process on 1 July 2019.

The Department advises that a future data breach of this nature is highly improbable since the correct restricted access security profiles are set in the live environment accessed by the public and will remain permanently at this security setting.

The Screening Unit had also taken steps to speak with the 15 students whose applications were viewed by 11 other students.

The Screening Unit Director personally attempted to telephone all 15 applicants on 7 June 2019 to tell these students that the Screening Unit had determined that their applications had been visible to the other students.

The Screening Unit has been successful in contacting 7 of these students by telephone. The Screening Unit has made repeated attempts to get in contact with the remaining 8 applicants but has been unsuccessful to date. The Screening Unit has invited these students by email to get in touch so the matter can be discussed over the phone and they can be informed that the personal data in their application form was able to be viewed by other students.

November 2019 and had difficulty verifying his identity online. Clause 6(1) telephoned the Screening Unit and a CSO assisted him with his verification. The audit trail shows that the CSO reset the verification method, at request, which allows the applicant to re login and choose a different verification method if needed. Clause 6(1) remained in the application where he had verified his identity and paid the application fee via BPoint.

However, the application was not submitted as the CSO reset the verification part of the application and this was not reselected. If the CSO did not make the change, clause 6(1) application would have been submitted. The CSO should have made it clear to impact of resetting the verification method and provided clear advice on what steps would have to be taken to complete the application.

Upon return from holiday, he telephoned the Screening Unit on 23 December 2019 to enquire about the status of his application and was informed by a CSO that the application was not submitted. The CSO then facilitated submission of the application.

It is acknowledged that in this circumstance, the system should have showed an error message that the application was not complete and should have prevented from proceeding to the payment stage.

The Screening Unit is investigating possible system improvements that can be implemented to prevent this issue from reoccurring.
