

Hello Janette, thank you for your reply. Of course I understand the Minister can't discuss the tender content, but the issues for us are more about the tender process.

Essentially, unless we partner with another organisation we have very little chance of success, as up to 80% of the new service is not what Shelter SA has any experience in. It is very difficult to discuss partnerships at this time - everyone I have spoken with, has not even looked at the tender, much less considered a partnership, due to the pandemic.

As such a small organisation we are also at a disadvantage in competitive tender processes as large agencies can subsume so many of the costs and show better value for money.

We are still quite shocked that there was no discussion or notice that this radical change to our funding would occur prior to an email to the whole sector, especially since we so recently had new KPIs accepted during the performance appraisal we completed.

If it was the intention that Shelter SA would simply adapt to a new way of delivering services, it is my view that the KPIs would have been set to reflect that by government, rather than a tender process that seems to deliberately exclude us as a peak body.

It is disappointing not to have any contact with Michelle to have open discussions, where in the past, this seemed to be quite easy to achieve.
