Freedom of information determination

I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Department of Human Services (DHS) on 4 June 2018 seeking access to:

Documents, such as audits, ministerial/executive briefings and attachments, reports, executive meeting minutes, internal correspondence limited to the Department CE/Deputy CE/Executive Directors showing:

- Foster/kinship/guardians or anyone who has been successful in their Working With Children check with criminal convictions including the types of criminal convictions.
- 2. How many children (including their age range) that have been placed in the care of Working With Children recipients with criminal convictions, including a breakdown of those criminal convictions.
- 3. The number of Working With Children clearances that have been revoked and why.
- 4. How many children (including their age range) removed from the care of someone following criminal charges, what those charges were, and within how many days.
- 5. How many children (including their age range) removed from the care of someone following a criminal conviction, what that conviction/s was/were, and within how many days.

Timeframe: Since 1 January, 2017.

Unfortunately, DHS was unable to make a determination on your application within the 30 days, therefore it is considered to be a 'deemed refusal' under section 19(2)(b) of the Act. However, DHS has continued to process your application outside of this timeframe. Section 19(2)(a) of the Act provides that an agency can release documents outside of the thirty day timeframe, and this is still taken to be a determination under the Act.

You were advised on 12 June 2018 that points one, two, four and five of your request more closely related to the Department for Child Protection (DCP), and those parts of your application had been transferred to DCP. DHS will address point three of your request.

One document, a spreadsheet, has been located that relates to point three and I have determined to release this to you. The document includes relevant data up to 29th June 2018. Please note that information not relevant to your application has been removed from this document.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, will be published on the agency's disclosure log. A copy of PC045 can be found at http://dpc.sa.gov.au/what-we-do/services-for-government/premier-and-cabinet-circulars.
