Freedom of information application

I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Office of the Minister for Human Services on 29 June 2018 seeking access to:

Since 17 March 2018, copies of any and all documents including but not limited to physical, electronic, or written briefs, minutes, emails, diary entries and any other correspondence) regarding the Benevolent Society.

Unfortunately, the Minister's Office was unable to make a determination on your application within the 30 days, therefore it is considered to be a 'deemed refusal' under section 19(2)(b) of the Act. However, our office has continued to process your application outside of this timeframe. Section 19(2)(a) of the Act provides that an agency can release documents outside of the thirty-day timeframe, and this is still taken to be a determination under the Act.

Ten documents have been located that fall within the scope of your application. I have determined to release one document in full and the remaining nine in part. Section 20(4) of the Act provides that if it is practicable to give access to a copy of a document with exempt matter deleted, and it appears that the applicant would wish to be given such a copy, the agency must give access to a copy of the document to this limited extent.

Document 1 contains information that is not relevant to your application and this has been removed.

Document 10 is an application by The Benevolent Society for project funding that contains detailed information regarding their proposed delivery of services. In the

current open disability market, release of this information could reasonably be expected to prejudice The Benevolent Society's business interests. I acknowledge that there is a strong public interest in the transparency of the government's funding processes. In my view, however, this is outweighed by the need to ensure that organisations submitting funding proposals are not disadvantaged by the release of detailed business information from such proposals that could be used by competitors. I have therefore determined this information exempt pursuant to clause 7(1)(c) of Schedule 1 to the Act.

Eight documents contain the mobile phone numbers of third parties. I consider that the release of this information would be an unreasonable disclosure of information related to the third parties' personal affairs and I have therefore determined it to be exempt pursuant to clause 6(1) of Schedule 1 of the Act.

Please find enclosed a copy of the documents, and a document schedule containing a brief description of the documents.

If you are dissatisfied with my determination, you can seek an internal review by writing to the Minister for Human Services as the Principal Officer of the agency. Your request should be sent within 30 days of your receipt of this letter.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, may/will be published on the agency's disclosure log. A copy of PC045 can be found at http://dpc.sa.gov.au/what-we-do/services-for-government/premier-and-cabinet-circulars.





Dear Premier

We take this opportunity to express significant concern at the recent public announcement by the NSW-based Benevolent Society that it has received a \$2.3m grant through the Future Jobs Fund.

While we note that it is a grant condition to create 230 FTE positions over the 4-year term of the agreement, it is questionable as to why South Australian taxpayer monies are being spent on attracting a New South Wales-based operator, rather than investing in locally-established disability sector operators.

You are on record as confirming that up to 150 job losses could be experienced by the sector amid reforms to disability funding (The Advertiser, 5 June 2018) at a time when many smaller SA-based operators are faced with unprecedented interstate and overseas competition.

Adding to that is the fact that the recent independent pricing review failed to consider the financial sustainability needs for sector participants, with NDIS pricing not covering the actual labour costs of a skilled and stable workforce, nor the infrastructure needed to provide quality support.

SA based Disability service providers have undertaken significant planning and investment to ensure a sustainable operating model is in place so we can continue to support South Australians with disability, but local disability employers may be left with no other option than to close their doors. No one wins if this is allowed to occur.

What is questionable is whether taxpayers believe that the fund should be used to support interstate organisations keen to cannibalise market share at the expense of SA-based employers.

South Australia already has the skills, experience, infrastructure, reputation and investment in capacity to deliver outstanding results for people with disability. The NDIS economic benefits analysis for SA suggests the creation of 6,197 jobs in the sector by the scheme's rollout completion in June 2019. With so much at stake, it is critical for SA to support local organisations and invest in itself at every opportunity – whether that is across the tourism, manufacturing, disability or other sectors.

Instead we now have a large NSW provider entering an already crowded market, with much of that taxpayer investment likely to head back over the border rather than contributing to our local prosperity.

While it is now too late to reverse this grant funding decision, I urge the South Australian Government to follow its New South Wales and Victorian counterparts and not outsource services beyond state boundaries and use any future grant funding to provide greater support to local disability organisations.

As Chair of the NDS State Committee, we request an urgent meeting to discuss this concern further.


