Freedom of information application

I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Office of the Minister for Human Services on 11 August 2020 seeking access to:

Between 1 May 2020 and 12 August 2020, all documents (including but not limited to physical, electronic or written briefs, internal discussion papers, minutes, emails, diary entries and any other correspondence) between the Minister and her office and Ms Kelly Vincent.

Ten documents have been identified as falling within the scope of your application and I have determined to release two documents in part and eight documents in full.

Document 1 contains information which has been removed as it is not relevant to your request.

Document 9 contains the mobile phone number of a departmental employee and I consider that the release of this information would be an unreasonable disclosure of information related to the employees' personal affairs, and have determined it to be exempt pursuant to clause 6(1) of Schedule 1 of the Act.

Please find enclosed a copy of the documents, and a document schedule containing a brief description of the documents.

If you are dissatisfied with my determination, you can seek an internal review by writing to the Minister for Human Services as the Principal Officer of the agency. Your request should be sent within 30 days of your receipt of this letter.



Thank you so much for today.

I have a few thoughts (personal, not necessarily those of the rest of the TF).

- Be careful of the word "caseworker". For paid workers, most people seem to prefer "support worker". "Carer" usually refers to a family member.
- I think one way to deal with the issue of the focus on the report not dealing with Ann Marie Smith directly is to argue that it it important to prevent people from getting into this situation in the first place. Corrective measures are important yes, but overly focussing on there to the neglect of others could end up leading to more AMss.
- How do you see the tracking of the outcomes from the report being tracked? Given the degree of interest I can see some benefit in there being publicly available information on how things are tracking, but I don't know how realistic this may be. I am not sure who would do this tracking, either. TF members may be keen but then if we're tracking the outcomes of our own report, there's a conflict?

- I think now might be a good time to get some info out there about how to report abuse and neglect, e.g. the abuse and neglect hotline. I am happy to develop some social media info/graphics on this.
- Similarly, it would be good to get some info out hon how to contribute to the next version of the report.
- in terms of developing an Easy English version of the final report, what resources/money to we have for this? It would be good to get someone onboard soon as this may take time.

Safeguarding Task Force Terms of Reference

Purpose

The Safeguarding Task Force, is a taskforce to examine the current gaps in oversight and safeguarding for people living with disability in South Australia.

The Task Force is co-chaired by Disability Advocate Dr David Caudrey and Disability Rights Advocate Kelly Vincent. Membership will include people with lived experience of disability, family members, a service provider as well as relevant government agencies, including the acting Principal Community Visitor Anne Gale.

The Task Force will consider gaps in safeguarding arrangement for people with disabilities in South Australia arising from the policies and practices of:

- the National Disability Insurance Agency
- the NDIS Quality and Safeguards Commission
- State Government instrumentalities.

The Task Force seeks to consider the gaps from a developmental, preventative and reactive perspective.

The Task Force will provide written reports including recommendations to the State Government regarding areas that need to be addressed urgently in order to safeguard South Australian citizens with disability.

Methodology

- Brief Task Force members prior to the first scheduled meeting.
- Seek information and advice from Task Force members, their networks and from other people who contribute to the Task Force deliberations
- Collate all information received and identify themes for rectifying policy and procedures for safeguarding
- Prepare and submit an interim report with urgent recommendations by 15 June 2020
- Prepare and submit a final report with full recommendations by 31 July 2020.

I have a few thoughts (personal, not necessarily those of the rest of the TF).

- Be careful of the word "caseworker". For paid workers, most people seem to prefer "support worker". "Carer" usually refers to a family member.
- I think one way to deal with the issue of the focus on the report not dealing with Ann Marie Smith directly is to argue that it it important to prevent people from getting into this situation in the first place. Corrective measures are important yes, but overly focusing on there to the neglect of others could end up leading to more AMss.
- How do you see the tracking of the outcomes from the report being tracked? Given the degree of interest I can see some benefit in there being publicly available information on how things are tracking, but I don't know how realistic this may be. I am not sure who would do this tracking, either. TF members may be keen but then if we're tracking the outcomes of our own report, there's a conflict?
- I think now might be a good time to get some info out there about how to report abuse and neglect, e.g. the abuse and neglect hotline. I am happy to develop some social media info/graphics on this.
- Similarly, it would be good to get some info out hon how to contribute to the next version of the report.

- in terms of developing an Easy English version of the final report, what resources/money to we have for this? It would be good to get someone onboard soon as this may take time.
