Volunteering SA&NT

Volunteering SA&NT (VSA&NT) is a membership-based organisation that plays a key role in advancing the volunteer sector in South Australia. The organisation is active in the advocacy, promotion and research of volunteering in South Australia, and at a national level.

VSA&NT was formed by Joy Noble and Mavis Reynolds in 1982, as the Volunteer Centre of South Australia. Their mission is to promote and celebrate volunteering and play a key leadership role for volunteers and over 2,000 volunteer organisations.

The Chair of the VSA&NT Board, Ms Karen Buenger, has been on the Board since 2009 and previously served as President on the Australasian Association for Managers of Volunteers board. Karen has over 15 years of experience in different fields of volunteer management, and is committed to supporting volunteer managers. She currently works for Better Impact Australia, supporting organisations to better manage their volunteers. Karen has an Advanced Diploma in Volunteer Management and other management qualifications.

VSA&NT, as with other state bodies such as Volunteering Queensland and Volunteering Victoria, provides support to Volunteering Australia's national initiatives, including the review and promotion of the National Standards for Involving Volunteers in Not-For-Profit Organisations, the completion of a revised Definition of Volunteering, and the promotion of National Volunteer week in May each year.

The event

The event is the VSA&NT Annual General Meeting breakfast. The VSA&NT Board, staff, volunteers and member organisations, all of whom represent a broad cross-section of the volunteer sector, will attend the AGM. You are invited to give a short address, welcome guests and acknowledge the work happening in South Australia to progress volunteering in

This year, the keynote speaker is Rachael Zaltron, General Manager of Backpacks 4 SA Kids. Annual General Meeting Volunteering SA&NT

- I would like to acknowledge this land that we meet on today is the traditional lands for the Kaurna people and that we respect their spiritual relationship with the country. I also acknowledge the Kaurna people as the custodians of the Adelaide region and that their cultural and heritage beliefs are still as important to the living Kaurna people today.
- VIPs attending: The Right Honourable The Lord Mayor of Adelaide, Martin Haese; Ms Nat Cook MP, Chairperson, Shadow Minister for Volunteers; Ms Karen Buenger, Chairperson, Volunteering SA&NT; Ms Evelyn O'Loughlin, Chief Executive Officer, Volunteering SA&NT.
- Thank you for inviting me to join you this morning and to address your 2018 Annual General Meeting. It is a privilege and a pleasure to be here with you all!
- As the Minister for Human Services, I would firstly like to acknowledge the founders of this organisation ... Joy Noble and Mavis Reynolds who, in 1982, opened the Volunteer Centre of South Australia.
- Without their vision, dedication and hard work, I imagine volunteering in South Australia would not be as prolific nor as well recognised, valued or organised as it is today.

- I would especially like to acknowledge the work done by Volunteering SA&NT to advance volunteering in the South Australian community, as well as influencing public policy at a national level.
- Volunteering SA&NT, as with other state bodies such as Volunteering Queensland and Volunteering Victoria, supports Volunteering Australia's national initiatives and policy advocacy.
- This includes reviewing volunteer guidelines and promoting National Volunteer week in May each year.
- I am aware that Volunteering SA&NT has had many highlights over the past 12 months, including celebrating the organisation's 35th anniversary. What a wonderful achievement!
- According to Harrison Research, the 2016 Volunteering in South Australia Survey Report shows that an estimated 68% of South Australians volunteer...what an extraordinary contribution!
- In terms of numbers, this equates to 920,000 people between the ages of 15-84 years, who contribute an estimated 1.76 million volunteer hours per week.

- I am particularly encouraged to learn that 21% of young people aged between 15-24 engage in formal volunteering.
- This is a significant increase from the 2014 survey that registered 14% in this age group.
- The Government of South Australia is committed to recognising the incredibly important contribution that volunteers make to the community, and to making it easier for people to volunteer.
- To this end, from 1 November 2018, all Department of Human Services screenings for volunteers, including volunteering with children and vulnerable people, will be free.
- Not only will this remove a potential barrier to volunteering, but it will contribute to making the community safer for everyone.
- As the Minister for Human Services, I am also pleased to confirm the Government's continued support for the Volunteering Strategy for South Australia beyond 2020.

- As members would be aware, this strategy is a world first partnership and a unique collaboration between State Government, the Local Government Association, Business SA and, of course, Volunteering SA&NT.
- The Volunteering Strategy aims to: build the capacity of volunteer involving organisations, promote the benefits of volunteering, raise the profile of volunteering, and lead the practice of high quality standards through continuous improvement and advocacy.
- I am particularly excited to hear about the 'Curriculum of Giving' pilot program, that aims to embed volunteering practices in all school curriculums.
- Led by the Department of Education, this work began and continues with involvement from the Volunteering Strategy, and is highly regarded.
- The potential to expand this work into schools across South Australia is significant. Imagine the impact of all students volunteering!

- Over the past 12 months, Volunteer Services (or the Office for Volunteers as it was known for many years), has continued to fund the WeDo Volunteering smartphone app, and has allocated approximately \$1m in grant funding to support volunteering in South Australia.
- This has helped Volunteering SA&NT with administrative costs and to support the corporate volunteering program.
- One-off grants are provided to volunteer-involving organisations through Grants SA, which is open for a number of funding rounds throughout the year.
- Youth volunteering is also a focus for the Government, and the Department funds programs that support both volunteering and young people including: the Youth Scholarship program; the UniSA Sustainable Online Community Engagement program; and the Community Voices program, run in collaboration with Flinders University.
- The Government manages a number of initiatives that recognise the contribution of volunteers in South Australia, including:
 - > the South Australian Volunteer Certificate of Appreciation

- ➤ The Premier's Certificate for Recognition for Outstanding Volunteer Service; and
- ➤ Hosting the Volunteers Day celebration event in June each year, which incorporates the presentation of the South Australian Volunteer Awards.
- There are many opportunities ahead for all of us, particularly as trends and people's volunteering habits are changing.
- We need to better understand and nurture young people's motivation for volunteering – including those in regional areas.
- It is vital that we communicate and build better messages that resonate with young people, particularly around life experience and personal and professional development benefits.
- If we can also foster organisational cultures that promote new incentives for volunteering, new modes of engagement between stakeholders, and workplaces that promote and embrace diversity, I believe that our community sector will be well prepared for the future.
- Once again, thank you for inviting me here this morning.
