#### Dear Ms Centofanti

I refer to your application under the *Freedom of Information Act 1991* (the FOI Act), received by the Department of Human Services (DHS) on 19 September 2022, seeking access to:

A copy of all documents (including but not limited to hard copy or electronic briefings, minutes, reports, emails, letters, meeting agendas, diary entries, placemats, event attendance records and any other correspondence) between Department of Human Services and the Minister for Human Services (including directly with staff within the office of the Minister for Human Services), relating to autism.

Timeframe: 21/03/2022 - 19/09/2022

I apologise that DHS did not make a determination within 30 days as required by the FOI Act. However, DHS has continued to process your application outside of this timeframe. Section 19(2)(a) of the Act provides that an agency can release documents outside of the thirty-day timeframe, and this is still taken to be a determination under the FOI Act.

Your office was advised that an initial search undertaken using the term 'autism' captured a very large amount of documentation and would likely exceed the \$1000 of free processing afforded to Members of Parliament. Your advisor, Ms Narelle Hards, subsequently advised that the scope of the request be amended from 'autism' to the more specific 'Autism Education Advisory Group' and 'Autism Inclusion Strategy'.

Eighteen documents were located that fit within the scope of your request and I have determined to release two documents in full and sixteen in part.

Please find enclosed a copy of the documents released and a document schedule containing a brief description of each document and determination in summary form.

#### Released in full

Documents 17 and 18 contain no exempt information and are being released to you in full.

### Released in part

Documents 1-12 relate to correspondence written by members of the public to the Premier's Office. These documents contain the personal information of the respective members of the public and I consider it would be unreasonable to disclose this information.

Documents 1, 4, 7, 10, 13, 14 and 16 contain the mobile phone numbers of government staff members. I consider this information to be the personal affairs of the respective staff members and it would be unreasonable to disclose this information.

I have determined documents 1-14 and 16 to be exempt pursuant to clause 6(1) of Schedule 1 of the Act which states:

A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Information that is not relevant to your request has been redacted from documents 4, 15 and 16.

In accordance with section 20(4) of the Act, I consider that you would wish for access to documents 1-16 after exempt information is removed and am therefore releasing these documents to you in part.

### Review rights and FOI disclosure log

If you are dissatisfied with my determination, you can seek an internal review by writing to the Chief Executive, DHS, as the Principal Officer of the agency. Your request should be sent within 30 days of your receipt of this letter.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, will be published on the agency's disclosure log. ### **PURPOSE**

To brief you on correspondence received by the Premier from CI 6(1) regarding the State Autism Strategy and to seek your approval of a draft response to CI 6(1)

### **KEY POINTS**

- has written to the Premier seeking information about the Labor Government's election commitment to develop a State Autism Strategy.
- Cl 6(1)
- The development of a State Autism Strategy will be led by the Department of Human Services (DHS) in partnership with the Department for Education and the Department for Health and Wellbeing.

 A key component in the development of this work will be consultation with South Australians with lived experience of autism and key partner agencies, including Autism SA.

#### DISCUSSION

has written to the Premier seeking information on the inclusion of people with lived experience of autism, both male and female, in the governance and development of the Autism Strategy.

In her email, CI 6(1) expresses her belief that current interventions and supports for people with autism are not 'neuro-affirmative' in nature. She is concerned that neurodiverse people are being 'trained' to abide by social norms driven by outdated 'behavioralist' approaches that do not view people holistically.

The South Australian Government has committed to develop a State Autism Strategy that operates within Inclusive SA (the State's Disability Inclusion Plan) and requires all public sector agencies to sign up to Autism SA's Autism Friendly Charter. This is part of broader commitments to make South Australia the 'Autism Friendly State,' including by:

- investing \$17.15 million to appoint an Autism Lead Teacher in every public primary school with clear outcomes and accountabilities.
- seeking to increase the number of autism-qualified staff in preschools.
- working with service providers including Autism SA to offer early intervention services in children's centres.
- investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

The State Autism Strategy will align with the principles and objectives of Inclusive SA and Australia's Disability Strategy 2021-2031.

The development of an Autism Strategy and requirement for government agencies to sign up to Autism SA's Autism Friendly Charter will build awareness and understanding to improve the way government services interact with people with autism and support better access and inclusion.

It is proposed that signing schools up to the Autism Friendly Charter be prioritised ahead of the commencement of qualified autism lead teachers in government primary schools from 2023. This activity will be led by the Department for Education. The Autism Strategy could commence development while this is occurring.

Signing up to the Autism Friendly Charter will also be included as a state-wide commitment under Inclusive SA and translated into deliverables in each State authority's Disability Access and Inclusion Plan.

DHS is committed to engaging with people living with disability and their families and carers in the development of all social inclusion policies and programs. While only one consultation mechanism, DHS' 12-member Disability Engagement Group was recently re-established to ensure greater representation of people with lived experience in the development of new intiatives.

Community and sector consultation for the Autism Strategy will reflect the diversity of people with lived experience, including women, Aboriginal and Torres Strait Islander people, culturally and linguistically diverse communities and those living regionally and remotely.

A draft response to CI 6(1) has been prepared for your consideration.

Thank you for your correspondence to the Premier of South Australia, the Honourable Peter Malinauskas MP, regarding the Labor Government's election commitment to develop a State Autism Strategy (the Strategy) and related community consultation. The Premier has asked me to respond on his behalf as this falls under my portfolio responsibility.

The Strategy is part of the new Government's broader commitment to make South Australia the 'Autism Friendly State' and will be led by the Department of Human Services in partnership with the Department for Education and the Department for Health and Wellbeing.

A key component of developing the Strategy will be listening to diverse South Australians with lived experience of autism and their families. This will ensure that the Autism Strategy is grounded in people's experience of neuro-diversity and takes an holistic view of what people need to reach their full potential. I recognise that gender is an important factor in how neurodiversity is both experienced and responded to.

The Strategy will operate within the State's Disability Inclusion Plan (Inclusive SA) and require all public sector agencies to sign up to Autism SA's Autism Friendly Charter. The Charter is an initiative designed to assist businesses, organisations and venues to create autism friendly places and services for people of all ages which is a great starting point.

Implementation of the Autism Strategy will also involve:

- investing \$17.15 million to appoint an Autism Lead Teacher in every public primary school with clear accountabilities of outcomes.
- seeking to increase the number of autism-qualified staff in preschools.
- working with service providers including Autism SA to offer early intervention services in children's centres.



• investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

Our commitment to genuine social inclusion involves creating opportunities for the voices of those with lived experience to be heard and to shape the Government's response.

I trust that this information addresses your queries and I encourage you to become involved as the Strategy is developed. DHS manages Disability Talk, an email subscription group comprised of people living with disability, their families, carers and members of the community who are invited to participate in various consultations. I am writing in regard to your Autism policy and I am wondering a few points,
I have not been able to access the outline of the policy itself so I thought I would ask a couple of questions.

Do you have autistic people who are able to and advocating for the needs of the autistic community on the board? And also, are you seeking Autistic guidance on the direction it is taking, both male and female perspectives as happen to present rather differently?

I ask because I am concerned about the current behavioralist approaches and would not want to see your policy simply prop up an outdated system as opposed to forging a new Neuro-affirmative pathway, with the support and foundation people truly need.

In a lot of cases (CI 6(1)) what I have observed is unfortunately a system that is out of date and using approaches that are not neuro-affirmative in nature. Which is to say that I see a lot of ND people being 'trained' to fit into social and emotional norms that are driven by outdated behavioralist approaches that do not treat people holistically.

I am also of the opinion that the entire schooling system is not designed in a child friendly way and is inherently damaging to our children, which I guess is not for this policy to contend with, however you would be great indeed to explore more play based and activity driven models.

### DISCUSSION

correspondence, he raises the critical value of respite and refers to a purpose built respite home called Auricht House. The facility was opened in Elizabeth North in 2005 as a respite centre for children with intellectual disabilities. Run by Centacare, it accommodated up to ten children. The House was named after mountain climber Mark Auricht who attempted to climb Mt Everest in 2001 to raise funds for a new respite service. Mr Auricht died during the climb and Centacare named the House in his honour. Auricht House operated as recently as 2018 but is now closed. According to Cl 6(1) this was due to a lack of ongoing funding. Due to the timing, the service may have been impacted by the introduction of the National Disability Insurance Scheme (NDIS).

There are a number of support options outlined below that can be accessed to support people with ASD and more specifically respite for family/carers, as part of the NDIS, in addition to state strategies. These include the following:

### **Autism SA**

Autism SA provides an extensive range of support and therapeutic services for individuals with autism, as well as parents, carers and families. The organisation's Kandu Day Options supports individuals with ASD to meet the goals in their NDIS Plans.

#### **National Carer Gateway**

During 2019-20, Commonwealth funding for services including the National Respite for Carers Program, Mental Health Respite and Commonwealth Respite and Carelink Centres, previously delivered by SA carer service providers, transitioned to the Integrated Carer Support Service. These services are now delivered through the national Carer Gateway and via Regional Delivery Partners (RDPs) in each state. Carers SA is the South Australian RDP.

Carers SA, and their partners Dementia Australia, Skylight, Life Without Barriers and NPY Women's Council, provide Commonwealth-funded RDP services for unpaid family carers including:

Once off practical support - Financial assistance to enable carers to access support. This
includes practical items that directly support carers to access education or employment.

 Carer Directed Packages - Financial packages for a range of practical supports to assist carers over a 12-month period. These packages may be used for planned respite, assistance with shopping, taxi transport to medical appointments and other services.

### **DHS - Community Connections Program**

Under SA Home and Community Care (HACC), DHS historically funded specialist carer service providers to deliver services for unpaid carers in South Australia. Following major national reforms including the launch of the Commonwealth Integrated Carer Support Service, My Aged Care and the NDIS, the SA HACC program ceased, and the Community Connections Program (CCP) was launched in 2021. CCP is a new program designed to support people who are at risk of experiencing social isolation and disconnection from services and communities and are not eligible for federal programs.

Through the CCP, Carer Support Partners support people to engage socially beyond the home, actively participate in local community activities, and increase social connection, community participation and inclusion. Additionally, Carer Support Partners deliver age-appropriate supports to young Carers under the age of 18, outside of the CCP. Carer Support partners are also funded to deliver breaks for Carers – which is different to the Gateway respite services - due to reported support limitations in Commonwealth-funded respite activities. This funding supports Carers SA as the centralised, single-entry point for all respite-type services in South Australia.

### **DHS-funded ASD services**

DHS currently funds Autism SA to provide a diagnostic assessment service and to facilitate a pathway into the National Disability Insurance Scheme (NDIS) for people with suspected ASD. This funding ceases on 30 June 2022 and discussions are underway regarding the continuation of this service and most effective use of available funding.

DHS also funds a range of providers that support people with an autism diagnosis through the DHS Exceptional Needs Unit. This funding is used for supports including financial contributions to accommodation, case management, mentoring, allied health assessments, and the administration of the Voluntary Out of Home Care (VOHC) Program. Almost all (95%) of VOHC clients are on the autism spectrum.

### State Autism Strategy

The Government of South Australia has committed to develop a State Autism Strategy that operates within Inclusive SA and requires all public sector agencies to sign up to Autism SA's Autism Friendly Charter. This is part of broader commitments to make South Australia the 'Autism Friendly State,' including by:

- investing \$17.15 million to appoint an Autism Lead Teacher in every public primary school with clear outcomes and accountabilities.
- seeking to increase the number of autism-qualified staff in preschools.
- working with service providers including Autism SA to offer early intervention services in children's centres.
- Investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

The Autism Friendly Charter is an initiative from Autism SA that has been designed to assist businesses, organisations and venues across Australia to create autism friendly places and services for people on the spectrum of all ages. Training to establish agencies as Autism Friendly can also be translated into South Australia's actions under Australia's Disability Strategy 2021-2031 and into Disability Access and Inclusion Plans under Inclusive SA. A briefing to outline work to progress the development of the strategy will be provided shortly, after a meeting with Ministerial staff to discuss options.

As you have pointed out in your correspondence, Auricht House is no longer operating as a respite service, however there are a number of other services for people with ASD and their families. Autism SA provides a range of support and therapeutic services for people with autism, as well as parents, carers and families.

Services are also available under the new national Carer Gateway and can be accessed through Carers SA, which provides services for unpaid carers including:

- Once off practical support financial assistance to enable carers to access support, education or employment.
- Carer Directed Packages financial packages for a range of practical supports
  to assist carers. Carers may be able to access funds over a 12-month period.
  These packages may be used for planned respite, assistance with shopping,
  taxi transport to medical appointments and other services.

The South Australian Government, through the Department of Human Services, funds services that support unpaid family carers through the Community Connections Program. Services are available across South Australia, with local program partners working with participants to determine the type of support they need to reach their personal and practical goals.

The Government has committed to making South Australia the 'Autism Friendly State' and to developing a State Autism Strategy that requires all public sector agencies to sign up to Autism SA's Autism Friendly Charter.





The Autism Friendly Charter is an Autism SA initiative designed to assist businesses, organisations and venues to create autism friendly places and services for people of all ages. Training to establish agencies as Autism Friendly can also be translated into South Australia's actions under Australia's Disability Strategy 2021-2031 and into statewide Disability Access and Inclusion Plans under Inclusive SA (the State's Disability Inclusion Plan).

Social inclusion is an important theme in Inclusive SA which values the contributions and rights of people living with disability, their families and supporters.

The South Australian Government has committed to the development of a State Autism Strategy that will operate under Inclusive SA (the State's Disability Inclusion Plan) and will require all public sector agencies to sign up to Autism SA's Autism Friendly Charter. This is part of broader commitments to make South Australia the 'Autism Friendly State,' which include:

- investing \$17.15 million to appoint an Autism Lead Teacher in every public primary school with clear outcomes and accountabilities
- seeking to increase the number of autism-qualified staff in preschools
- working with service providers including Autism SA to offer early intervention services in children's centres
- investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

The State Autism Strategy will align with the principles and objectives of Inclusive SA and Australia's Disability Strategy 2021-2031. The Social Inclusion Directorate will provide a briefing regarding next steps in the development of the Strategy in near future.

The development of a State Autism Strategy and the requirement for government agencies to sign up to Autism SA's Autism Friendly Charter will build awareness and understanding to improve the way government services interact with people with autism and support better access and inclusion.

It is proposed that signing schools up to the Autism Friendly Charter be prioritised ahead of the commencement of qualified autism lead teachers in government primary schools from 2023. The Social Inclusion Directorate have commenced work to scope this in consultation with the Department for Education.

Signing up to the Autism Friendly Charter will also be included as a state-wide commitment under Inclusive SA and translated into deliverables in each State authority's Disability Access and Inclusion Plan.



### Additional supports for autism



The development of the Strategy will be led by DHS in consultation with the sector, including Autism SA, and South Australians with lived experience of autism, and their families.

Development of the Strategy is part of broader commitments to make South Australia the 'Autism Friendly State,' which include:

- investing \$17.15 million to appoint an Autism Lead Teacher in every public primary school with clear outcomes and accountabilities
- · seeking to increase the number of autism-qualified staff in preschools
- working with service providers including Autism SA to offer early intervention services in children's centres
- investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

The Strategy will require all government agencies to sign up to an Autism Charter, which is being scoped at present.

DHS will establish a steering committee to oversee the project to develop the Strategy which will be chaired by DHS and include representation from people with lived experience of autism, the disability sector, the Department for Education and the Department for Health and Wellbeing, with the involvement of other public sector agencies as relevant.

The department has commenced early engagement on the Strategy with the Department for Education directly and other agencies through the South Australian Disability Reform Intergovernmental Committee (SADRIC), which includes membership from more than 10 state government agencies.

Their priorities will be encompassed in the discussion paper being developed to commence the co-design process with the disability sector, people with lived experience and the broader community.

If the Minister wishes, an executive from DHS can make themselves available to attend the meeting with Autism SA to provide insights and further information.



# Background and information

## What is happening?

On 15 August 2022, the Premier of South Australia announced (in a national first) a state Assistant Minister for Autism to lead positive change and address the challenges and barriers being faced by autistic people.

While improving disability inclusion in general continues to be a priority of the State Government, more dedicated action is required in building public understanding and establishing positive policy improvements for the <sup>1</sup>autistic community.

The Strategy will include key priority areas where autistic individuals face particular challenges and barriers, including health and wellbeing, community attitudes, workforce, education and the interface with the National Disability Inclusion Scheme (NDIS). The Strategy will align to the State Disability Inclusion Plan (Inclusive SA) and play an important role in shaping future policies and strategies.

This commitment of the State Government to develop the Strategy will only succeed if the autistic community is given the opportunity to freely participate and have their voices heard. By working together, the State Government and the community can ensure that people diagnosed with autism will have access to the services and support they need to participate in our society free of barriers.

## Why do we need a State Autism Strategy?

A State Autism Strategy is needed to support a dedicated and coordinated effort from government in meeting the access and inclusion needs of the autistic community.

As at 30 June 2022, the National Disability Insurance Agency Quarterly Report for Quarter 4, 2021-2022 indicates that autism is currently the largest primary disability group in South Australia (39%). Nationally, 34% of NDIS participants have autism as their primary disability group.

It is noted there have been significant changes to how autism is diagnosed in the past decade. This, along with our better understanding of autism, may be a contributing factor to the growing number of young people receiving an autism diagnosis when compared to older demographics.

Early intervention is crucial, and that intervention is dependent on early diagnosis and support strategies being in place and working effectively. The State Government has responded by committing to:

- \$28.79 million over four years to appoint an Autism Inclusion Teacher in every public primary school from the beginning of Term 1, 2023
- an increase to the number of autism-qualified staff in preschools
- early intervention services in children's centres
- develop a State Autism Strategy that operates with Inclusive SA and requires all State
   Government agencies to sign up to an Autism Charter
- investing \$50 million to fund 100 additional speech pathologists, occupational therapists, psychologists and counsellors for access in the public school system.

## The consultation process

Through this public consultation, the State Government wish to invite submissions that respond to key questions that will inform the scope and content of a draft Strategy. There will be a further consultation process to ensure that the actions ultimately proposed in the Strategy reflect the information and feedback provided and will result in meaningful enhancements to the lives of autistic people in South Australia.

There are a number of key steps in the development process for the Strategy, the first of which is this discussion paper which will commence the co-design process.

Targeted focus groups with people with lived experience are also being established, in addition to advisory committees and a public forum to inform the development of the Strategy.

#### **Public Consultation – Discussion Paper**

This discussion paper has been prepared to support the public consultation and contains ideas and questions that will help inform the shape of the Strategy and the actions to be pursued by the State Government.

The public consultation gives anyone interested in participating in the development of the Strategy the opportunity to submit responses to questions outlined in this consultation paper. Everyone is invited to offer their feedback, opinions and insights into the current supports and services provided and on the specific issues they feel need to be addressed by the Strategy.

#### **Public Consultation – Draft Strategy**

Following the conclusion of the public consultation on this discussion paper, a draft Strategy will be developed that responds to the insights gained from all of the information received.

Once the draft Strategy has been finalised, there will be a second public consultation to ensure that everyone has an opportunity to participate in the finalisation of actions to be adopted by the State Government.

## Topic 1: Defining autism

Every person on the autism spectrum is an individual with unique qualities, strengths and support needs. There is not one way that an autistic individual experiences the world, this is why the term 'spectrum' is used – to reflect the fact that every individual's lived experience of autism is different.

Defining autism for the purposes of the Strategy is a complex issue, but one that is fundamental to supporting community understanding and attitudes over time.

The following definitions have been identified:

#### **Australian Autism Alliance**

autism is a complex life-long neurodevelopmental condition resulting from differences in the brain and nervous system. Many people meet the diagnostic criteria for autism spectrum disorder. Autism is characterised by differences in social communication and the presence of restrictive, repetitive and/or sensory behaviours or interests. No two people experience autism in exactly the same way; with individual strengths and difficulties across the areas of social communication, behaviour, language, thinking, learning, processing, and daily living skills.

To live their best lives autistic people require acceptance, accommodation, participation, and/ or appropriate individualised support that can vary and evolve over time.

# Australian Institute of Health and Wellbeing

Autism spectrum disorder (also simply termed autism) is a persistent developmental disorder, characterised by symptoms evident from early childhood. These symptoms include difficulty in social interaction, restricted or repetitive patterns of behaviour and impaired communication skills. However, these may not be recognised until later, when social demands, such as those related to schooling, become greater.

There is no definitive test for autism; instead, diagnosis is made on the basis of developmental assessments and behavioural observations. This snapshot explores the prevalence and characteristics of people with autism, and their use of disability support services.

#### **World Health Organisation**

**Autism spectrum disorders (ASD)** are a diverse group of conditions. They are characterised by some degree of difficulty with social interaction and communication. Other characteristics are atypical patterns of activities and behaviours, such as difficulty with transition from one activity to another, a focus on details and unusual reactions to sensations.

## **Topic 2: Community attitudes**

Understanding the needs and challenges faced by autistic people is critical to ensuring that all State Government agencies adopt appropriate inclusive policies and practices, and the community is better informed.

### Creating an autism affirming society

All people, including autistic people, have the right to enjoy their community and experience the highest level of physical and mental health. However, autistic people are often subject to stigma and discrimination, including limited opportunities to engage and participate in their communities which negatively impacts their physical and mental health.

When a person lives with disability, it does not completely or wholly define who they are. Autism, just like any other disability, is a natural and ordinary part of human diversity and autistic people can live full lives with interests, desires and dreams – just like any other Australian.

#### Language is important

Person first language aims to put the person before their disability and includes terminology such as 'person with autism', 'people on the autism spectrum', or 'individual with autism'.

*Identity first language* reflects the belief that being autistic is a core part of a person's identity and includes terminology such as 'autistic person', 'autistic individual' or 'autistic'.

Reflecting the diversity of language preferences within the community, both person-first and identity-first language is usually adopted.

Autistic people should not be patronised or objectified through stereotypical pitying portrayals that paint them as sufferers or inspiration-based clichés that portray them as heroes. A person is not automatically vulnerable because of their autism diagnosis. They are individuals who lead valuable and multi-dimensional lives. Likewise, they are not superheroes just because they live with an autism diagnosis.

#### **State Autism Charter**

The State Government intends to develop a State Autism Charter, that all State Government agencies will be required to adopt. The State Autism Charter will be co-designed with people with lived experience and developed in conjunction with the Strategy. The Charter requires community input to ensure it is responsive to the needs of autistic people and demonstrates appropriate accountability.

It is intended that the State Autism Charter will provide State Government agencies with a series of principles and commitments to ensure that they are responsive to the needs of autistic people

within their unique context and maintain a strong accountability for considering how their services respond to, and interact with, the autistic community.

Principles identified for Inclusive SA that could be adopted for the State Autism Charter include:

- Fundamental human rights, responsibilities and autonomy
- Individual worth and dignity
- Participation in social economic life
- The right to realise physical, social, sexual, reproductive, emotional and intellectual capacities
- The right to make decisions, including supported decisions and to take risks
- Access to information in appropriate forms
- Respect for cultural and linguistic diversity, age, gender, sexual orientation and religious beliefs
- Rights to privacy and confidentiality
- Live free from neglect, abuse and exploitation
- Rights to pursue complaints and access justice
- Acknowledge and respect the crucial role of families, carers and friendship activities
- Respect the needs and rights of children as they develop
- Acknowledge and respect the abilities, strengths, goals and needs of people living with disability.

## Topic 3: Health and wellbeing

A broad range of interventions, from early childhood and across the life span, can optimise the development, health, wellbeing and quality of life of autistic people, where required. Timely access to early evidence-based psychosocial interventions can improve the ability of autistic people to communicate effectively and interact socially.

#### **Health factors**

It is important that, once autism has been diagnosed, children, adolescents and adults with autism and their carers are offered relevant information, services, referrals, and practical support, in accordance with their individual and evolving needs and preferences.

Recent data shows that autistic people have less access to health care, an increased risk for comorbidities, and have more anxiety and depression, than people without disability.

Furthermore, the healthcare needs of autistic people are often complex and require a range of integrated services, that include health promotion, care and rehabilitation. Collaboration and interface between government services and the NDIS is important to respond to complex needs.

#### **Wellbeing factors**

Social exclusion contributes to poor mental health outcomes for autistic people and restricts access to programs and supports that may significantly improve their overall health and wellbeing.

The Strategy, in connection with Inclusive SA, should respond to the wellbeing barriers facing autistic people through the implementation of State Government agency Disability Access and Inclusion Plans (DAIPs) Inclusive SA - State authority plans.

# Topic 4: The built environment

The built environment is an influential factor in the quality of life of autistic people. The opportunity for autistic people to autonomously interact with the built environment is often compromised (and sometimes denied) due to constraints arising from the mismatch between their specific needs and the 'built form.'

Several studies have emphasised how the altered perception of sensory stimuli and processing of information coming from the environment is one of the main issues experienced by autistic people, including:

- adverse responses to specific sounds or textures, smells or lighting
- distress at changes to routine, locations, travel, interior design.

The necessity to consider the living environments on the basis of the specific needs of autistic people has gained increasing importance in urban planning and urban design fields over the past decade. Therefore, it is essential to investigate further how the built environment in our existing (and future) infrastructure impacts autistic people and how it can be re-designed or reorganised to promote their autonomy and to enhance their overall quality of life.

# Topic 5: Education and employment

#### **Education**

The Department for Education has been tasked to appoint an autism inclusion teacher in every public primary school in South Australia from Term 1, 2023. Up to one day per week funding will be offered to free up teachers to take on the role. Furthermore, there will be an increase in autism inclusion staff in preschools and further allied health supports through the State's children's centres.

These initiatives sit outside the scope of this discussion paper as they are deliverables already in development.

#### **Employment**

Participation in the workforce is important for social inclusion and economic independence, however despite the varied and diverse skillset of autistic people which could prove invaluable to an employer, they continue to encounter barriers to entering the workforce.

According to the Australian Bureau of Statistics, in 2018 the unemployment rate for people with autism was 34.1%, more than three times the rate for people with disability (10.3%) and almost eight times the rate of people without disability (4.6%).
