Freedom of information application

I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Office of the Minister for Human Services on 3 September 2018 seeking access to:

From 28 June 2018 through 3 September 2018, an index of all briefs a) Received by the Minister's office; b) Requested by the Minister's office; c) Generated by the Minister's office; d) Returned to the department after consideration by the Minister or Minister's staff.

Unfortunately, the Minister's Office was unable to make a determination on your application within the 30 days, therefore it is considered to be a 'deemed refusal' under section 19(2)(b) of the Act. However, our office has continued to process your application outside of this timeframe. Section 19(2)(a) of the Act provides that an agency can release documents outside of the thirty-day timeframe, and this is still taken to be a determination under the Act.

A report has been generated from our records management system listing briefings detailed in your request. This document falls within the scope of your application and I have determined to release it in full. Please find enclosed a copy of the document.
