#### Freedom of information application

I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Office of the Minister for Human Services on 17 July 2019 seeking access to:

A copy of any current documentation which lists all staff and/or job titles in the Minister's office, including department staff appointed to the Minister's office and a copy of the current Confidential Minister's Directory.

The purpose of this letter is to advise you of my determination.

Two documents have been identified and I have determined to release the documents that fall within the scope of your application in part.

Section 20(4) of the Act provides that if it is practicable to give access to a copy of a document with exempt matter deleted, and it appears that the applicant would wish to be given such a copy, the agency must give access to a copy of the document to this limited extent. This document contains the mobile phone numbers of employees within the Minister's office. I consider that the release of this information would be an unreasonable disclosure of information related to the employees' personal affairs and have determined it to be exempt pursuant to clause 6(1) of Schedule 1 of the Act.

Please find enclosed a copy of the documents, and a document schedule containing a brief description of the documents.
