Freedom of information application

I refer to your application under the Freedom of Information Act 1991 (the Act), received by the Office of the Minister for Human Services on 12 October 2018 seeking access to:

Copies of any and all documents (including but not limited to physical and electronic material) regarding DHS Election commitment monitoring.

Three documents fall within the scope of your application, and I have determined that two documents are to be released in full and one document to be released in part.

Document 2 contains extracts of documents which were specifically prepared for submission to Cabinet, information which is exempt pursuant to clause 1(1)(c) of Schedule 1 of the Act, I have determined to refuse access in part to this document. The document contains matter regarding incoming government briefs the release of which would disclose information concerning a decision by Cabinet.

If you are dissatisfied with my determination, you can seek an internal review by writing to the Minister for Human Services as the Principal Officer of the agency. Your request should be sent within 30 days of your receipt of this letter.

KEY POINTS

- During the 2018 South Australian State Election, the Government announced a total of 15 election commitments to be delivered by the Department of Human Services (DHS), as well as five to be delivered by Renewal SA.
- With the housing functions of Renewal SA due to be transferred to DHS, you will also have responsibility for these additional five commitments.
- Of these commitments, two are to be delivered within 30 days and another four within the first 100 days.
- The Office of the Chief Executive will be responsible for monitoring and reporting on the implementation of the election commitments by DHS.

DISCUSSION

The election commitments to be implemented by DHS set out in Attachment 1. Of these, the two commitments to be delivered within the first 30 days are as follows:

- 1. hosting a domestic violence stakeholder roundtable to expedite reform
- 2. initiating full conditions assessment of Housing SA properties to support strategic asset management plan.

We will be seeking your advice and direction at an early meeting in respect of the delivery of these commitments, and management of budget implications.

The DHS divisions responsible for each commitment will then prepare an implementation plan to ensure the election commitments are successfully delivered by the department (refer to the template in Attachment 2).

Pending Machinery of Government changes to transfer the housing functions of Renewal SA to DHS, the Office of the Chief Executive and Housing SA will work with Renewal SA to ensure the five commitments which are allocated to Renewal SA are being progressed, in particular the commitment to initiate a full conditions assessment of Housing SA properties within the first 30 days.

Once an approach is agreed, each lead division will also be required to complete a regular monitoring report on progress towards achieving the commitments made during the 2018 election. The information provided by divisions will be incorporated into a whole-of-department progress report, which will be put on the agenda at regular intervals for discussion with you during your weekly meetings with the DHS Chief Executive.

The Department of the Premier and Cabinet is also expected to initiate a whole-ofgovernment monitoring system for all election commitments and DHS will be expected to progress and report on the commitments allocated to the department.
