#### PURPOSE

To provide background information to inform your response to the invitation from Mr Graham Brown, Chief Executive Officer of Baptist Care SA (BCSA) to attend lunch at their Inner City Services at WestCare.

### **KEY POINTS**

 Mr Brown has invited you to join him for lunch at WestCare, which is located at Millers Court, Adelaide, to meet at a time convenient to you.

#### DISCUSSION

BCSA commenced in 1913 as the West End Baptist Mission, providing services to people in Adelaide who were homeless. Over the past 100 years, BCSA has expanded its services to include vulnerable and disadvantaged groups in the community

BCSA's services include Aboriginal services; homelessness services; chaplaincy services; camping and adventure programs, employment, education and training; mental health and disability services; out-of-home care; refugee services; welfare and youth services; and camping and adventure programs. Services are provided from a number of sites across South Australia.

In 2018-19, BCSA will receive state funding of \$10.48 million comprised of:

- South Australian Home and Community Care (SA HACC) funding, Specialist Services funding and Office for Youth funding to support clients in supported accommodation settings (4.5 million) and in group homes (3.4 million)
- administration of the Community Links and Karpandi Elder Women's Program (\$0.45 million)
- outreach homelessness service, community transition worker, and youth and Aboriginalspecific homelessness service (\$2 million)
- youth mentoring program \$(0.25 million).

The majority of BCSA's disability clients commenced the transition to the National Disability Insurance Scheme (NDIS) on 1 July 2017 when people aged 18-64 years began the transition process. In 2017-18, nine clients transitioned, which resulted in a reduction of approximately \$1.6 million in state funding. As at 28 September 2018, no clients have transitioned in 2018-19.

BCSA was also awarded funding in Round 2 of the NDIS Information Linkages and Capacity Building National Readiness Grants:

- \$560,351 over two years (2018-2020) for the Able & Deadly project for Aboriginal people and those with disability who are homeless or have psychosocial or cognitive disability, with the aim of removing barriers to accessing support from the NDIS or mainstream service providers
- \$167,637 over two years (2018-2020) for the Connections project, working with people with disability and their families to design and deliver community inclusion workshops across South Australia.

BCSA believes it is well positioned as an NDIS service provider with the development of its NDIS Project Team as part of the Future Jobs Fund to support a broad organisational transition to the NDIS, and procurement of a new electronic client management system to support a mobile workforce in the delivery of services.

BCSA's Inner City Homelessness Services is located at the WestCare Centre in Adelaide, which provides meals and emergency food parcels for homeless and disadvantaged South Australians. The Centre also meets immediate needs with hot showers, clean laundry, general advocacy, and connections to nursing, legal and government services. It receives hundreds of thousands of donated goods each year, e.g. blankets, warm clothes and non-perishable food.

In 2017-18, the Inner City Homelessness Services distributed:

- 388 vouchers to single people
- 434 vouchers to families
- approximately 1,000 food parcels to single people
- over 1,000 food parcels to families.
