I refer to your application under the *Freedom of Information Act 1991* (the Act), received by the Office of the Minister for Human Services on 15 May 2021 seeking access to:

All documents (including but not limited to physical, electronic, or written briefs, internal discussion papers, minutes, emails, diary entries and any other correspondence) regarding the Quentin Kenihan Inclusive Playspace. Specifically, the minutes of any meetings mentioning construction/development/budget.

Three documents have been identified as falling within the scope of your application and I have determined to release two documents in full and refuse one document in full.

Document 1 is an Annual Report that is publicly available, and I have determined to refuse this document in full under section 20S (1)(b) of Schedule 1 of the Act.
