I refer to an application for internal review under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Human Services (DHS) on 29 November 2021 seeking access to:

All documents including notes, memos, briefings, correspondence, emails or other electronic communications referencing a free food service in Whitmore Square, including but not limited to a soup/street kitchen.

Timeframe: 1/01/2020 to 10/09/2021

The application was submitted by Ms Stacey Lee, ABC News, but I understand that you are now acting on her behalf with regards to this application.

I apologise that DHS was unable to make a determination on your initial application within the required 30-day timeframe, therefore it was considered to be a 'deemed refusal' under section 19(2)(b) of the FOI Act. DHS was also unable to meet the timeframe for making a determination on your application for internal review and is therefore said to have confirmed its original determination of a 'deemed refusal' under section 29(5) of the FOI Act.

Release of documents under Section 19(2a) of the FOI Act

Section 19(2a) states that an agency can give access to a document outside of the legislated timeframes for dealing with an application and this is said to still be a determination under the FOI Act.

DHS has located 52 documents that fall within the scope of your application and these documents are being released to you under section 19(2a). Please note that mobile phone numbers have been redacted from 33 documents, information that would have been considered exempt under clause 6(1) were DHS to have made a determination within required timeframes. Additionally, information not relevant to your application has been redacted from six documents

We have been advised of a couple of organisations who are providing charity in the area. Most notably:

- William's Wardrobe handing out food, clothes and blankets to people. Matt Nairn has been in touch with these people, they aren't a registered charity
- Adelaide Day Centre Soup Van and Communist Party food provision: City of Adelaide Compliance and Permits team have been working to add some permit restrictions around food provision in public spaces so we can better manage this and also redirect where there are negative consequences to this activity – such as drawing more people to an area. I will get an update from the team on how they are going with this, and am also interested to see if these groups attend during the lockdown.
- Fred's Van and Orange Sky Laundry operate from Vinnies Men's shelter, but I understand that these
 activities are better coordinated through Vinnies.

I'll bring this up again with Matt and see if we can get status update on these services during and post lockdown.







Hi Lois

Sorry for the delay in this response – I needed to get confirmation from our compliance areas.

No, they aren't allowed to drive cars onto the park, but the reason they would have not been pulled up on this before is we have Parking and Information Officers on over the weekend, who would ordinarily monitor, but it is likely they would have thought it was an organised event with a permit, so haven't taken any action. Many of us were unaware this activity was taking place for some time. The reason we took steps to establish the permit with them was to clear up what they can and can't do as an organised activity on the Park Lands.

The permit conversation took place a couple of weeks ago, but Casey from Community Union Defence League reached out to the Permits team again today to clarify some conditions and requirements of the permit. I understand that they have agreed to submit the required information to obtain a permit, but maybe not before the original deadline of this Friday that we gave them.

The permit is being facilitated under s222 of the Local Government Act. This requires a permit to be obtained from Council when using the public space for business purposes, even when the business is not for profit.

I think that if the Taskforce makes a recommendation that the Council consider limiting or prohibiting the activity of providing free food for charity in public spaces, we would consider how this can be applied and enforced. I'd have to get some further advice, but might require some level of engagement with Elected Members. I can keep discussing this with the Taskforce as the Cabinet Submission is prepared.

Hi Lois.

We previously didn't have a permit system for the provision of free food and have established a process to regulate it better. The Communist party were contacted by our permits team and advised they would need to fill out paperwork and provide details so we can manage the activity and put some conditions around it. My understanding was that this conversation went well and they have until this Friday to complete their paperwork, but haven't done so as yet.

They were also advised that shortly some major works were commencing in Whitmore Square (I will send that information through separately) that would impact on their operation and we could work with them to see if another location would be better suited. We also haven't had a response on that.

The permit will continue to chase up and work with them, but eventually it is going to be difficult for them to operate when there is some construction going on.

I write on behalf of Ms Casey McEwan and the volunteers of the street kitchen in Whitmore Square, Adelaide, which operates between 11:30am and 1:30pm every Sunday, and provides free food and clothing to the homeless and disadvantaged.

I am informed that the volunteers of the street kitchen in Whitmore Square were approached by representatives from the Department of Human Services; the Adelaide City Council; and SAPOL, to stop the street kitchen from operating in Whitmore Square.

Ms McEwan states that the Council has since mandated a Food Vendors Permit, which is both costly and a time-consuming process for a non-for-profit service. Accordingly, Ms McEwan questions the directive believing it is *discriminatory* and unprincipled.

Given the number of people currently requiring urgent and necessary support as they struggle through our economic crisis, the obstruction of a service providing essential care for those less fortunate is reprehensible.

I respectfully ask that you support the street kitchen in Whitmore Square so that it can continue providing consistent support for those less fortunate in our community.

PURPOSE

To provide a draft response for the Premier to Casey McEwan, Adelaide Secretary, Australian Communist Party, in relation to an interaction with a Department of Human Services (DHS) official regarding their street kitchen operating at Ivaritji (Whitmore Square).

KEY POINTS

- The Premier received correspondence from Ms Casey McEwan, Australian Communist Party (ACP) alleging a DHS representative requested that the ACP cease operating their street kitchen in Ivaritji (Whitmore Square).
- A further letter was received from Steve Georganas MP, on behalf of Ms McEwan and the volunteers of the street kitchen.
- The ACP stated that they have been asked to stop providing free food and clothing to the homeless and other disadvantaged people.

The Chief Executive DHS Chairs the Safety and Wellbeing Taskforce (the Taskforce)
 established to address concerns of public drinking and anti-social and unsafe behaviour
 in the parklands.

- The Taskforce has received feedback from Whitmore Square residents and elders concerned about public health, amenity and food and other wastage arising from the unregulated provision of food and clothing in isolation of other coordinated support services.
- In addition, residents have raised matters associated with vehicles driving across the square without proper traffic management or appropriate permits.
- In this capacity, the Chief Executive approached the group on Sunday 1 August 2021 in Ivaritji (Whitmore Square) to discuss concerns about the welfare responses being provided by groups such as the ACP.
- In addition, it is understood that the ACP have been operating the street kitchen without the relevant and necessary permit from the Adelaide City Council and the Chief Executive sought to confirm this and clarify the group's responsibilities in this regard.
- The Chief Executive also indicated that the Taskforce was keen to discuss the matter in more detail and that a representative from the Department of the Premier and Cabinet's Aboriginal Affairs and Reconciliation division would be in contact to facilitate these discussions.
- The Communist Party are encouraged to work with the Toward Home Homelessness Alliance, a consortium of services led by Lutheran Care, that work with people experiencing homelessness or requiring other services.

RISKS/SENSITIVITIES

As the complaint relates to the Chief Executive, this briefing has been signed by the Executive Director, Community and Family Services.

DISCUSSION

Originally founded on 30 October 1920, the ACP was re-established in its current incarnation on 28 June 2019 and advocates for a socialist Australia.

In an email to the Premier on 2 August 2021, Ms Casey McEwan, Adelaide Secretary of the ACP, stated that a representative of DHS approached the street kitchen and requested that the kitchen cease the distribution of free food and clothing to the homeless and other disadvantaged people.

The Chief Executive, DHS Chairs the Safety and Wellbeing Taskforce to address concerns of public drinking and anti-social and unsafe behaviour in the parklands. The Safety and Wellbeing Taskforce consists of state and local government senior staff, including Aboriginal Affairs and Reconciliation, and is working to address the social and public safety issues linked to chronic public alcohol consumption and rough sleeping by people, particularly in Ivaritji (Whitmore Square). DHS, SAPOL and Adelaide City Council have been meeting with concerned residents around Ivaritji as the situation has seriously deteriorated.



Hi Nick

As you know I have been chairing this Taskforce regarding concerns raised by the Lord Mayor about remote visitors who are are sleeping rough in parklands. This group was appointed by Cabinet on the recommendation of the CEC and includes a number of departments, the Adelaide City Council and the Port Adelaide Enfield Council.

Over the last few months we have been analysing this very complex problem and have started to have some success by working with all Taskforce members, various NGO services and Aboriginal Communities. During Lockdown we ran some intensive and innovative interventions which were successful in arranging for some people to return home after many months.

However, there is a lot still to do and it will take time and resources. The health and safety issues that have been raised by Adelaide City Council are significant for the community but very severe for these visitors. Recently a young man died in the south city parklands. He is associated with a group who frequent Whitmore Square.

We have now had some excellent conversations with elders and we're in discussions to engage aboriginal people to work with us and communicate with these groups in their languages to find what they need and how we can assist to break what is a very harmful alcohol abuse cycle.

The situation in Whitmore square is now the most complex and involves considerable concern about the volatility from police and neighbours. The taskforce has been discussing how the service models that we have around the area which have been there for many years may be serving to entrenched some problems.

A couple of weeks ago I spoke to a group related to the Communist party who had a marquee on the Square and were handing out food and goods. I advised them that we were concerned about their approach and that someone from Aboriginal Affairs would be in touch to these discuss concerns. I also told them that I understood that they were required to have a permit from council and I would speak to Council about this.

Unbeknown to me it would appear that last week council refused to provide the permit to conduct this soup kitchen at Whitmore square. I am told they have been advised they should go to a different area.

As a result of this I was contacted on Friday afternoon by ABC TV who have been told that I am attempting to evict them from Whitmore square because I am a neighbour and a Director of Sparkke at the Whitmore.

This is most certainly not my intent or motivation, I actually believe we are starting to get to the point where we can do some very good work here to assist some people trapped in an horrendous cycle and I do not want to undermine that work in any way.

I should say that to the best of my knowledge any issues in the Square have never been raised as a business concern by Sparkke. To the contrary I was told on the weekend that Sparrke provides food to the charities around the square and has always had an eye to responsible alcohol sales in this area.

However, given this has been raised as a perceived conflict, I propose that I step down as Chair of the Taskforce and appoint Alex Reid who is our Executive Director of Community and Family Services to take my spot. This work is very important and undoubtedly any actions taken, or not taken, by the Taskforce will be controversial in such a complex space.

I would also like to provide an update on the Taskforce to date to the Thriving SA Council this week as part of this handover.

I would be keen to discuss this with you when you have a chance.

I hope this email finds you well.

I am following up on the email sent to you last month (a copy of which can be found below) and a chat I had with Casey last week in regards to the permit process.

Casey and I discussed the need for public liability insurance and I wanted to confirm that we can (on a case by case basis) accept lower levels of public liability insurance. If you have any type of insurance cover in place, please forward a copy of the certificate to us with a permit application and we will assess it from there.

One key point I'd like to add about the MFV permits for groups servicing the community is that there is no fee involved.

Do you have any upcoming activities planned to service the community in a public area? If so, please submit a permit application as soon as possible so that we can work with you to setup a permit in a suitable location before the proposed date.

Please be reminded that under section 222 of the Local Government Act and Roads By-Law 2018, you must hold a Council permit before conducting an activity such as servicing the community on Council land. If you conduct an activity in a public area without a permit, a Council Officer may approach you to discuss the activity and advise you of possible enforcement action that can be taken in future.

As you have been advised, Whitmore Square can no longer be used as a location for servicing the community until further notice. SA Police have suggested West Terrace as a suitable location to relocate to. If you would like to discuss your operations and alternative locations, please contact Viviana our project officer on 8203 7113 for advice.

Good Afternoon Robert

Thank you for taking the time to speak with Tony a little while back in regards to your not-for-profit activities within the City of Adelaide.

As discussed, organisations that provide food to the homeless and vulnerable are required to hold a mobile food vending (MFV) permit issued by the City of Adelaide (this is requirement under section 222 of the Local Government Act and the Roads By-Law 2018).

To qualify for a permit you must demonstrate that you provide a pathway to a specialist homelessness support service. For more information on the services available in the City of Adelaide please visit <u>SA Homelessness Alliance</u>.

You can apply for a MFV permit online here by providing the following:

• Details of the homelessness support service you connect people with.

- A Certificate of Currency with a minimum public liability cover of \$20 million and noting The City of Adelaide as an interested party.
- A copy of your Food Business Notification with the local Council where your vehicle is housed, or where the majority of the food preparation and food handling occurs.
- Written proof of notification of your trade waste disposal agreement with your local council or SA Water.
- A photo of your vehicle set-up (or designs showing how it will look).

Please submit an application by Friday 6 August 2021.

By holding a current permit, the City of Adelaide will be able to contact you to advise of any upcoming works or activities that will impact the use of certain areas. Whitmore Square is one such area that currently, due to both scheduled works and other activities, cannot be used until further notice.

Once you have been issued a MFV permit, you will also have the flexibility to use other locations within the City of Adelaide. Further details regarding suitable locations can be found on our <u>website</u>.

PURPOSE

To provide a draft response for the Premier to Casey McEwan, Adelaide Secretary, Australian Communist Party, in relation to an interaction with a Department of Human Services (DHS) official regarding their street kitchen operating at Ivaritji (Whitmore Square).

KEY POINTS

- The Premier received correspondence from Ms Casey McEwan, Australian Communist Party (ACP) alleging a DHS representative requested that the ACP cease operating their street kitchen in Ivaritji (Whitmore Square).
- A further letter was received from Steve Georganas MP, on behalf of Ms McEwan and the volunteers of the street kitchen.
- The ACP stated that they have been asked to stop providing free food and clothing to the homeless and other disadvantaged people.
- The Chief Executive DHS chairs the Safety and Wellbeing Taskforce (the Taskforce)
 established to address concerns of public drinking and anti-social and unsafe behaviour
 in the parklands.

OFFICIAL

- The Taskforce has received feedback from Whitmore Square residents and elders concerned about public health, amenity and food and other wastage arising from the unregulated provision of food and clothing in isolation of other coordinated support services.
- In addition, residents have raised matters associated with vehicles driving across the square without proper traffic management or appropriate permits.
- In this capacity, the Chief Executive approached the group on Sunday 1 August 2021 in Ivaritji (Whitmore Square) to discuss concerns about the welfare responses being provided by groups such as the ACP.
- In addition, it is understood that the ACP have been operating the street kitchen without the relevant and necessary permit from the Adelaide City Council and the Chief Executive sought to confirm this and clarify the group's responsibilities in this regard.
- The Chief Executive also indicated that the Taskforce was keen to discuss the matter in more detail and that a representative from the Department of the Premier and Cabinet's Aboriginal Affairs and Reconciliation division would be in contact to facilitate these discussions.
- The Communist Party are encouraged to work with the Toward Home Homelessness Alliance, a consortium of services led by Lutheran Care, that work with people experiencing homelessness or requiring other services.

RISKS/SENSITIVITIES

As the complaint relates to the Chief Executive, this briefing has been signed by the Executive Director, Community and Family Services.

DISCUSSION

Originally founded on 30 October 1920, the ACP was re-established in its current incarnation on 28 June 2019 and advocates for a socialist Australia.

In an email to the Premier on 2 August 2021, Ms Casey McEwan, Adelaide Secretary of the ACP, stated that a representative of DHS approached the street kitchen and requested that the kitchen cease the distribution of free food and clothing to the homeless and other disadvantaged people.

The Taskforce consists of state and local government senior staff, including Aboriginal Affairs and Reconciliation, and is working to address the social and public safety issues linked to chronic public alcohol consumption and rough sleeping by people, particularly in Ivaritji (Whitmore Square). DHS, SAPOL and Adelaide City Council have been meeting with concerned residents around Ivaritji as the situation has seriously deteriorated.

The department recognises that, while well meaning, the provision of informal welfare responses are short term solutions that are not addressing the root causes of public drinking and unsafe behaviour in public spaces.

The Communist Party are encouraged to work with the Toward Home Homelessness Alliance, who are funded to work with people experiencing homelessness and requiring other services.

The Wellbeing and Safety Taskforce was approved through Cabinet. Its mandate is to establish a high-level cross-government working group, in conjunction with Councils, to develop strategies

to reduce anti social behaviour from vulnerable groups. This include visitors to Adelaide from remote Aboriginal communities. The ultimate aim is to keep both residents and visitors safe and return people to their communities.

On Sunday 1 August, I was walking across Whitmore Square on my way home and noticed a group who had four cars and a tent erected on the Square.

I explained I was Chair of the Taskforce, and enquired what they were doing and if they had a permit to be on the Square.

They identified themselves as the Communist Party and said they did not have a permit.

I told them they needed a permit from Adelaide City Council to operate on Whitmore Square.

I also explained the Taskforce was working to identify all groups who currently provided services from the Square. This was so Aboriginal Affairs could make contact and discuss a way to find an alternative location/s and solutions to reduce dependency on services and keep visitors and residents safe.

Of note, work on the redevelopment of Whitmore Square is now underway following two years of consultation. It may be inappropriate for groups to continue delivering services while this is happening.

Stacey we would be happy to work with you on a story about the Taskforce.

Roles and Responsibilities of Taskforce

The SMC Working Group will:

- Respect the rights of visitors and residents to enjoy and share the public realm.
- Consider drivers for the perceived increase in anti-social behaviour associated with visitors to Adelaide from remote Aboriginal communities.
- Gather and review information relating to prevalence and potential causes.
- Develop options for short, medium and long-term strategies and planning to keep the community, both visitors and residents safe.
- Utilise cross-Government resources to develop and implement responses to the needs of communities.



The taskforce had discussed that some traditional services may not be assisting people out of this complex problem and an officer from Aboriginal Affairs had been assigned to try to speak to each of the groups that are not part of the funded service system to discuss concerns. The taskforce is in the process of identifying and contacting these groups

On Sunday 1 August, I was walking across Whitmore Square on my way home and noticed a group who had four cars and a tent erected on the Square.

I explained I was Chair of the Taskforce, and enquired what they were doing and if they had a permit to be on the Square.

They identified themselves as the Communist Party and said they did not have a permit.

I told them they needed a permit from Adelaide City Council to drive cars and run services on the Parklands. They admitted that they knew a permit was required.

I advised them that the Taskforce had concerns that services around the area may not be assisting vulnerable people in the way they meant to. I said that Aboriginal Affairs would be in touch to discuss these concerns however I would raise with Council that they did not have a permit.

The next day Council advised me that they were already working with this group about getting a permit.

At no stage has DHS or the Taskforce asked for any group to be moved by Council or SAPOL. Discussions about the most effective service model are still underway with elders and community leaders.

I also explained the Taskforce was working to identify all groups who currently provided services from the Square. This was so Aboriginal Affairs could make contact and discuss a way to find an alternative location/s and solutions to reduce dependency on services and keep visitors and residents safe.

Of note, work on the redevelopment of Whitmore Square is now underway following consultation that occurred over the last few years by Adelaide City Council. It may be inappropriate for groups to continue delivering services while this is happening.

I understand that Council had advised the Communist Party that they would need to move their operation due to the upgrade works in early July





During the engagement process the Taskforce had engaged an Aboriginal led organisation to speak with people in a culturally appropriate way and provide detailed information and data on the people within Whitmore square. This

This provided insightful information on the diversity of the group who are meeting at Whitemore Square, who have a variety of presenting issues and social dynamics for the reasons why they find themselves at Whitmore square.

The taskforce has spoken to Aboriginal community leaders who have provided feedback to the taskforce on how the group should be provided access to the service sector, and support from the local city council and the NGO sector. Transcript:

Whitmore Square in Adelaide's CBD has long been a safe place for people experiencing homelessness with many services based around that part of the city. But now there's a concerted push to move some of them elsewhere.

A street kitchen run by the Australian Communist Party has been told it's no longer allowed to operate in the square. Party members have complained about a senior public servant who they say has tried to intimidate them but they're not backing down. Here's this week's special report.

For two years, every Sunday, this street kitchen has been offering food to some of Adelaide's homeless.

It started with one table and three men handing out around 30 meals but now it's grown into a much larger operation.

McEwan: "We give out anywhere between 250 to 300 meals a week."

They also supply donated clothes and hygiene packs for those sleeping rough. For many of the volunteers here, it's all part of a higher calling. The kitchen flies under the flag of the Australian Communist Party, run by 17-year-old Casey McEwan.

McEwan: "We have never signed up or actively tried to sign up anybody who's come to the kitchen for the party at all."

Briton: "I always thought of it as part of our political commitment and it's certainly part of the glue for our organisation."

While the food's warmly welcomed by the people the volunteers serve, the kitchen's been controversial with nearby residents and business owners. It doesn't have a permit to operate and council has told the volunteers one won't been approved for Whitmore Square, instead suggesting West Terrace.

Café owner Harris: "I think it's a positive thing to move it as long as they're still offering the service and the parklands are a really open, peaceful space so I think, you know, the more space people have, the better."

Whitmore Square is undergoing gentrification with the council and state government funding a \$900,000 redevelopment.

Resident Straccia: "The other day, a lady from the council came here to talk about the beautification of the square and my response to her was 'You can't put lipstick on a pig'."

Tony Straccia says it's becoming increasingly difficult to live and own a business on the square.

"I experience waking up every morning to some form of surprise, whether it be people sleeping in the foyer of my building, whether it be plants being damaged, whether it be defecation, you know, on my footpath."

In recent weeks the soup kitchen has been visited by police and council officials, who told the volunteers they need a permit to operate. Then came a visit earlier this month from a government official.

Briton: "She's identified herself as Lois. She said that she was from the Department of Human Services."

Communist Party founder Bob Briton said she voiced her concerns.

Briton: "Well you are creating a problem and I'll be using the resources at my disposal to make sure that you don't come back next week. It was a fairly tense, not very pleasant exchange."

Only later did the volunteers discover that 'Lois' was Lois Boswell, the chief executive of the department.

McEwan: "It feels a bit scary or monolithic if you will for a person in such a high position to come down in person."

The groups says she told them they were creating a dependence amongst the local homeless population.

Briton: "We're there once a week. We can hardly provide a service on which people can depend."

They later wrote a letter of complaint to the Premier.

Ms Boswell told the ABC she made the Sunday afternoon visit in her capacity as the chair of a new taskforce which has been set up to reduce anti-social and sometimes violent behaviour associated with visitors to Adelaide from remote Aboriginal communities. She said she advised the volunteers the taskforce had concerns that some services in the area may not be assisting vulnerable people in the way they were intended to.

Briton: "In the end I did feel it was an effort to intimidate us so we don't come back the following week."

The Communists have also questioned whether Ms Boswell has a conflict of interest, pointing out she lives nearby and owns a share in a pub on the square which prides itself on its dedication to social causes.

McEwan: "I think that there would be a great conflict of interest, definitely."

Briton: "Maybe the interests of the pub and the convenience or whatever of the clientele would be better if there weren't gatherings of homeless people there."

Lois Boswell did not respond to the ABC's written questions about whether she has a conflict of interest but in an earlier phone conversation she says her part ownership of the pub has no impact on her roles as head of the taskforce and of the department.

She did say at no stage has either group asked for anyone to be moved by council or SAPOL. Ms Boswell says she did not know the council had advised the group they would need to move until now.

To the volunteers and others, this location makes sense. There's a men's shelter run by Vinnies, the Salvation Army on the corner, St Luke's church here behind me, Anglicare SA is around the corner, and so is BaptistCare, which earlier this year was part of an alliance which won the funding to run the city's homeless services in a major shakeup of the sector.

Sandeman: "This has been the place for homeless people in Adelaide for a long, long time. It's where they feel safe. It's where they come for their services."

Vox pops: "I don't think we should be shunting people off as undesirable. I think we should all inhabit it together."

"How would we feel if we were banished further and further away."

Other pop-up services which also operate on the square say no one's approached them to move locations.

The Communist Street Kitchen plans to dig in its heels...

McEwan: "We would prefer and would definitely defend our wanting to be in Whitmore Square."



Last week organisers of the street kitchen were approached by representatives of the Department of Human Services, who claimed they were doing so on behalf of the SA State Premier. The spokeswoman, called Lois, said she would be using the resources available to her to make sure we don't set up our service in Whitmore Square any more.

This follows approaches from the Police and the Adelaide City Council seeking to shut down the free food and clothing distribution to the homeless and other disadvantaged people. The police claimed we were attracting homeless people to the area and that businesses and residents weren't happy about this. The Council is seeking to close us down by obliging us to apply for a Food Vendors Permit, which is an expensive bureaucratic process and demanded even though we aren't selling anything.

The Department claims we are causing a problem by creating dependence among the Aboriginal community. We reject this claim. We do our best to bring some relief to the homeless but there is no way people could depend on our service for long-term survival. We wish we could do more to help as the situation of many of the people approaching us for solidarity is urgent and dangerous. They need housing, not harassment.

Be assured that the volunteers of the street kitchen will do everything in their power to maintain our presence in Whitmore Square every Sunday between 11:30am and 1:30pm. We would welcome your support in this matter and your intervention to prevent this obstruction to services to the homeless of Adelaide.



2. Long version of info to advise ABC response

The Wellbeing and Safety Taskforce was approved through Cabinet. Its mandate is to establish a high-level cross-government working group, in conjunction with Councils, to develop strategies

to reduce anti social behaviour from vulnerable groups. This includea visitors to Adelaide from remote Aboriginal communities. The ultimate aim is to keep both residents and visitors safe and return people to their communities. - I think we may want to say it is made up of senior executives from

ADD SENTENCE OR TWO HERE ABOUT HAVING THE SUPPORT OF INDIGENOUS ELDERS WHO ARE WORKING WITH US. This needs to come from Dale

Elders are very concerned about people being caught in cycles of severe alcohol consumption in these times and being unable to return to country during COVID for various reasons.

During the recent lockdown the Taskforce piloted some innovative service models to assist people with health needs, court matters and opportunities to return home.

The taskforce had discussed that some traditional services may not be assisting people out of this complex problem and an officer from Aboriginal Affairs had been assigned to try to speak to each of the groups that are not part of the funded service system to discuss concerns. The taskforce is in the process of identifying and contacting these groups

On Sunday 1 August, I was walking across Whitmore Square on my way home and noticed a group who had four cars and a tent erected on the Square.

I explained I was Chair of the Taskforce, and enquired what they were doing and if they had a permit to be on the Square.

They identified themselves as the Communist Party and said they did not have a permit.

I told them they needed a permit from Adelaide City Council to drive cars and run services on the Parklands. They admitted that they knew a permit was required.

I advised them that the Taskforce had concerns that services around the area may not be assisting vulnerable people in the way they meant to. I said that Aboriginal Affairs would be in touch to discuss these concerns however I would raise with Council that they did not have a permit.

The next day Council advised me that they were already working with this group about getting a permit.

At no stage has DHS or the Taskforce asked for any group to be moved by Council or SAPOL. Discussions about the most effective service model are still underway with elders and community leaders.

Of note, work on the redevelopment of Whitmore Square is now underway following consultation that occurred over the last few years by Adelaide City Council.

I understand that Council had advised the Communist Party that they would need to move their operation due to the upgrade works in early July



I advised them that the Taskforce had concerns that services around the area may not be assisting vulnerable people in the way they meant to. I said that Aboriginal Affairs would be in touch to discuss these concerns however I would raise with Council that they did not have a permit.

The next day Council advised me that they were already working with this group about getting a permit.

At no stage has DHS or the Taskforce asked for any group to be moved by Council or SAPOL. Discussions about the most effective service model are still underway with elders and community leaders.

Of note, work on the redevelopment of Whitmore Square is now underway following consultation that occurred over the last few years by Adelaide City Council.

Some of you may have seen a story that aired on ABC yesterday about a pop-up street kitchen operating without a permit on Whitmore Square. The story touched on the work of the South Australian Government's Safety and Wellbeing Taskforce. I want to clear up any confusion there might be on the positive work of the taskforce. This is an important opportunity to talk about how we

address very complex social issues and why we need to innovate longstanding service models if we want to truly make a difference in people's lives.

The Safety and Wellbeing Taskforce was established by the Chief Executive Council following direction of Cabinet. Its mandate is to improve the safety and wellbeing of vulnerable visitors to Adelaide from remote communities and reduce anti-social behaviour across a number of areas in the CBD and Port Adelaide. The ultimate aim is to keep both visitors and residents safe and facilitate the return to country for those people who wish to go home to their community. The taskforce is made up senior staff from state and local government agencies, including the division of Aboriginal Affairs and Reconciliation from the Department of Premier and Cabinet. Crucially, the taskforce has spoken with Aboriginal Elders who provided advice that they are very concerned about people being caught in cycles of severe alcohol consumption and are unable to return to country.

I regularly visit and talk with people and service about issues on the ground. Earlier this month when I came across people packing up a marquee in Whitmore Square, I asked who they were and stated they needed a permit from Council. I also said we were seeking to identify and contact the services in the area to discuss concerns that some service models may not be assisting vulnerable people out of very complex problems in the way they mean to. I advised that a member of the Taskforce would be in touch with them. At no stage did I or the taskforce ask for any group to be moved. I've since learnt that Council had earlier advised the group that they would need to move their operation due to the upgrade works in Whitmore Square.

The recent lockdown and ongoing challenges posed by COVID-19 make it more urgent than ever that we discuss longstanding service models and consider new and better ways of making a truly positive impact for the people we serve. The taskforce has piloted some innovative service models to fit with the current trends and assist people with health needs, court matters and opportunities to return home. There was recently a fantastic first meeting with APY Executive and Kaurna Yerta Aboriginal Cooperation members, with support raised for a Memorandum of Understanding that will make it clear how these two groups can work in partnership. Elders agreed they, and their respective board members, need to be at the table to work in collaboration with government agencies when service mapping conversations occur. The taskforce is in the process of identifying and contacting relevant services, including those not part of the funded service system, to discuss service models and new approaches.

I want to thank all the elders, community leaders, staff, agencies and service providers that have been involved in this important work to date. I reiterate my deep commitment to this work.

This important work will not create change overnight but it will put us in a strong position to develop effective strategies that support everyone's wellbeing and safety. 

There was recently a fantastic first meeting with APY Executive and Kaurna Yerta Aboriginal Corporation members, with support raised for a Memorandum of Understanding that will make it clear how these two nations can work in partnership. Elders agreed they, and their respective board members, need to be at the table to work in collaboration with government agencies when service mapping conversations occur. The Taskforce is in the process of identifying and contacting relevant services, including those not part of the funded service system, to discuss service models and new approaches.

It is important to note that neither I nor the Taskforce asked the Adelaide City Council to move the street kitchen. The Council informed us, however, that they had told this group in June that they would need to move during the redevelopment of Whitmore Square.

There have been so many people - from Elders and community leaders, to government agencies and service providers - that have been involved in this significant work to date, and I am incredibly grateful for their continued commitment and support. I would especially like to acknowledge the many DHS staff in the Community and Family Services Division who responded so quickly to support the vulnerable cohort during the recent lockdown and who are now working with SA Health and the SA Housing Authority to develop longer-term solutions for supporting this community through the COVID-19 pandemic.

E-News: Permits for Food Services in Public Spaces

Organisations that provide food to the homeless and vulnerable in public spaces are required to hold a mobile food vending (MFV) permit issued by the City of Adelaide. This is requirement under section 222 of the *Local Government Act SA 1999* and the *Roads By-Law 2018*.

This is to ensure the health and safety of service provider and the public, and to minimise or remove unintended consequences as an outcome of the activity. For example, we have received complaints about some public areas being left in a less than ideal state, which a permit can help manage.

In June 2021, CoA employees telephoned six organisations identified as operating a food service without a permit in public spaces in the City. It was explained to each of these organisations that they would need to apply for a permit, at no cost, with appropriate insurances, in order to comply with the Act and the By-Law.

One of these organisations was the Community Union Defence League.

These phone calls were followed up with an email to each organisation confirming the requirements and advising the process to obtain a permit.

To date, three of the organisations contacted have applied for a permit.

CoA has not yet received a permit application from the Community Union Defence League.

When the Community Union Defence League were advised of the need to apply for a mobile food vending (MFV) permit, they were also notified that until further notice, Whitmore Square cannot be used as a location for servicing the community. This is due to the scheduled works and other activities

associated with the Whitmore Square Greening Project. The League were advised that SA Police have suggested West Terrace as a suitable location for their service to relocate to. An offer was made to discuss their operations and alternative locations and to answer any questions the League may have about the permit or the application process.

Council has been involved in the State Government's Wellbeing and Safety Taskforce to identify the issues faced by vulnerable Aboriginal People from remote communities and develop appropriate responses to support their health and safety while in Adelaide. This Taskforce also recognises the impact that alcohol related anti-social behaviour has on the local community and is committed to developing sustainable, long term responses to a complex issue. The Taskforce is addressing the issues that present with people visiting from remote communities and sleeping rough in public spaces in Whitmore Square, North Terrace, the Park Lands, in public areas in Port Adelaide Enfield Council, as well as overcrowding in SA Housing Authority tenancies in the suburbs.

A coordinated service response where multiagency support is delivered with clear pathways for people to access what they need and to stay safe is the most appropriate way to achieve sustainable outcomes for vulnerable people. Council's process of managing service delivery in public spaces aims to support this approach by social services.

Hi everyone,

Like so many of you, I have been heartbroken by the reports coming out of Afghanistan and seeing the real fear and desperation of the people in Kabul seeking a path to safety for themselves and their families. Proudly, we are doing our part to help as South Australia welcomes arrivals from Afghanistan into hotel quarantine. Our Interpreting and Translating Centre is providing both male and female accredited interpreters and translators, as part of South Australia's cross-government effort to support our new arrivals in a sensitive way during their quarantine period and as appropriate into the future. Our COVID-19 Response team has also been liaising with the NGO sector and SA Health's hotel quarantine team to coordinate the immediate provision of essential supplies for the new arrivals to support them through their 14-day hotel quarantine, and provide much needed comfort for the many babies, children and teenagers. This is a vital service at a critical time that will enable the Afghan arrivals to access the range of supports they need.

Some of you may also have seen a story that aired on the ABC about a pop-up street kitchen operating without a permit in Whitmore Square. The story touched on the work of the South Australian Government's Safety and Wellbeing Taskforce, and I thought was an important opportunity to talk about the positive work of this group. The Taskforce addresses very complex social issues and the need to improve service models if we want to truly make a difference in people's lives.

The Safety and Wellbeing Taskforce was established by the Chief Executive Council following direction of Cabinet. Its purpose is to improve the safety and wellbeing of vulnerable visitors to Adelaide from remote communities, and reduce anti-social behaviour across a number of areas in the CBD and Port Adelaide. The ultimate aim is to keep both visitors and residents safe and facilitate the return to Country for those people who wish to go home to their community. The Taskforce is made up senior staff from state and local government agencies, including the division of Aboriginal Affairs and Reconciliation from the Department of the Premier and Cabinet.

Crucially, the Taskforce has spoken with Aboriginal Elders who provided advice that they are very concerned about people being caught in cycles of severe alcohol consumption and unable to return to Country. The Taskforce has also engaged the services of Iwiri, an Aboriginal Corporation for Anangu (Pitjantjatjara/Yankunytjatjara) people in Adelaide, who are providing cultural advice in policy development, service coordination and cultural outreach. Iwiri provides the Taskforce with an important perspective through a lens of family, community, culture and knowledge, ensuring the work and recommendations of the Taskforce meet the unique needs of remote Aboriginal visitors. I believe

strongly that the only and best way to better meet the needs of mobile and visiting Aboriginal populations is to facilitate Aboriginal leadership and partnerships, like these, that empower the Aboriginal community.

The recent lockdown and ongoing challenges posed by COVID-19 make it more urgent than ever that we discuss longstanding service models and consider new and better ways of making a truly positive impact for the people we serve. The Taskforce has piloted some innovative ideas to fit with the current trends and assist people with health needs, court matters and opportunities to return home for people.

Recently, Dale Agius, our Senior Manager, Aboriginal Practice and Partnerships facilitated the first official meeting between APY Executive and Kaurna Yerta Aboriginal Corporation members in 15 years, with support raised for a Memorandum of Understanding that will make it clear how these two nations can work in partnership in a culturally respective manner. Critically, Elders also agreed they, and their respective board members, need to work in collaboration with government agencies when service conversations occur and will develop Nation Group cultural protocols. The Taskforce is in the process of identifying and contacting relevant services, including those not part of the funded service system, to discuss service models and new approaches.

It is important to note that neither I nor the Taskforce asked the Adelaide City Council to move the street kitchen. However, Council recently informed us, that they had told this group in June that they would need to move during the redevelopment of Whitmore Square.



I appreciate the response we received regarding the recent threats made to the Community Union Defence Leagues Street kitchen in Whitmore Square, however I feel the response was inadequate regarding the situation. Since sending the email detailing the situation it has been confirmed that the spokesperson on behalf of the Department of Human Services that approached us on August the 1st, was Lois Boswell the Chief Executive Officer of the Department of Human Services.

We feel, as she claimed she had approached us on the authority of the Premier that a more appropriate response is required. Lois herself has confirmed she was at the square the day we reported, furthermore she confirmed that she holds a stake in the Spark at Whitmore Pub across the road from Whitmore Square. It seems that there may be a conflict of interest on behalf of Lois in this situation as the contents of the conversation that we detailed in our previous email revealed.

Furthermore, the City of Adelaide council has suggested we move from Whitmore Square as we will no longer be able to operate there. The Community Union Defence League does not recognise this demand and hope you will allow us to continue providing our services to the much broader Adelaide homeless community branching further than just the Aboriginal groups. There is a great need for our services, and we cannot afford to be shifting around.

The Community Union Defence League intends to continue providing services to the vulnerable in Whitmore Square and hope we can enjoy your support.
